# State of Kuwait Public Authority of Housing Welfare

## Invitation Pre-Qualifying International Companies to Participate in Tenders Announced by the Public Authority of Housing Welfare (PAHW)

The public Authority of Housing Welfare (PAHW) Of invites local and international companies (on the condition of having an official contract with a certified Kuwaiti partner or agent) that are willing to pre-qualify at the PAHW to participate in announced tenders for executing City Housing Projects; Infra-structure applicants must meet the followings conditions:

1. Basic probative company documents and papers should be clear, valid, recently dated.
2. Qualification documents and all other documents should be presented in Arabic for local companies, and foreign companies should present their documents and all others papers in Arabic or English.
3. For foreign companies all their submittal must be attested by their competent authority and Kuwait embassy of the respective country.
4. Companies applying for pre-qualification should meet all the conditions stated in the general tenders law.
5. The Companies applying for pre-qualification should fall into one of these categories:
  - a. local contractors classified in the first category specialized in executing road and buildings works (based on the latest ranking of the centralized tenders committee)
  - b. international contractors specialized in roads and buildings works.participating companies can obtain a CD that contains the contact forms and qualification documents from the PAHW located in : (South Al-Surah, third floor, Documents contracts department-qualification of contractors) with a fee of (2000 KWD/CD) two thousand Kuwaiti Dinars nonrefundable, starting Sunday 24/MAR/2013 during working hours (from 8 am to 1:00pm).

Please note that the deadline for submitting a completed qualification documents and that is on Sunday 30/June/2013 at 1:00 pm Sharp.

The companies that have been qualified by the PAHW and their qualification is 3 years overdue are required to renew their data based on their own qualification documents, which will be provided to them on a CD for a nonrefundable fee of (200 KWD/CD) two hundred Kuwaiti Dinars.

Note that, PAHW will not consider qualifying any company that submits its qualification documents or incomplete documentations after the deadline furthermore; PAHW will not consider these company names in participating in future tenders.

After the approval of the authority's entity on the qualified companies list, an announcement will appear in the official gazette (AL-Kuwait-Yom) with qualified companies' names.
