Invitation for Bids

Baalbek & Tyre Archaeological Project - Phase 1 - Conservation

This invitation for bids follows the general procurement notice for this project that appeared in the issue of the UN Development Business No. 619 dated November 30, 2003 and dg-market dated June 23, 2009.

The Lebanese Republic intends to apply payments for goods, works, related services and consulting services to be produced under the Cultural Heritage and Urban Development Project (CHUD). This project is co-financed by the International Bank for Reconstruction and Development (IBRD), the Agence Française de Dévelopment (AFD), the Italian Government (Department for Development Cooperation), and the Government of France. Bidding for contracts financed by the World Bank will be governed by its eligibility rules and procedures.

The Council for Development and Reconstruction, the project's executing agency, intends to apply part of the proceeds of this loan to payments under the contracts for "Banibek & Tyre Archaeological Project - Phase 1 - Conservation".

Works will include:

- 1. Works of Package 1 Baalbek:
 - Section B Structural Strengthening:
 Propylaea, Hexagonal Court Vaults Reconstruction, Hexagonal Court Lintels
 Consolidation, Great Court Northern Exedrae, Perimeter Wall, Arab Tower, Architraves
 Adjacent to Arab Tower, Bacchus Temple, and Venus Temple.
 - Section C Surface Conservation:
 Exodra in the Orest Court, Bacchus Temple, and Venus Temple.

2. Works of Package 2 - Tyre:

- Section B Structural Strongthening:
 Palaestra Colonnade, Arena, Roman Baths, Roman Arch, Monumental Tomb, and Church with Oarden.
- Section C Surface Conservation:
- Roman Bath, Grande Allee, Colombarium, Monumental Tomb, Church with Garden, Sarcophagi, Roman Arch, and Church near the Arch.

The construction period is 24 months.

The Council for Development and Reconstruction (CDR) now invites scaled blds from cligible bidders for the work package described above. Bidding will be conducted through the international competitive bidding procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2006 (revised March and April 2007, May 2010, August 2010), and is open to all bidders from cligible source countries as defined in the guidelines.

Bidders will be subject to post qualification and shall meet the following qualification criteria:

- minimum average annual volume of construction work in the last five years shall be USS
 million;
- successful experience within the last Ten years as prime contractor (to comply with these requirements, works shall be at least 70% complete):
 - a. in at least two (2) works contracts in public works with at least one of a value not less than Five (5) MU\$; and
 - in at least one (1) works contract in the execution of Archaeological Conservation Works, with a value of at least Two (2) Million US \$; and
 - c. in at least one (1) works contract in the Conservation of Archaeological Structures & Surfaces, with a value of at least Five hundred (500) thousand US \$:
- a Project Manager with ten years experience including no less than Seven years in works of

equivalent nature:

liquid assets and/or credit facilities of no less than US\$ 0.8 million, and 5.

an Archaeologist with field experience in works contract related to Archeological

Excavation, and

a Surface conservation specialist (experience in works contracts related to archaeological sites. He/she must be graduated in a well known School of Restoration, such as, the Istituto Centrale del Restauro, Rome; Opificio delle Pietre Dure, Florence; the KunstAkademie, Wien; La Cambre and the IRPA, Bruxolles, L'IFROA, Paris, the Courtauld. Institute, London, and similarly accredited and renown institutions and must have a specific field experience in the Conservation of porous building materials), and

an Architect restorer with field experience in works contracts related to restoration of old 7.

buildings and façades.

Full details of the qualification criteria are given in Section III. Evaluation and Qualification Criteria in the Tender Documents.

Interested eligible bidders may obtain further information from and inspect the bidding documents at the Council for Development and Reconstruction at the address below from 8:00 to 13:00 Beirut local times. A complete set of bidding documents in English may be purchased by interested bidders from the address below on application in person and upon payment of a nonrefundable fee of Five Hundred US Dollars (US\$ 500) for each set, starting Monday, July 4th 2011. The method of payment will be through a bank certified check in favor of the Council for Development and Reconstruction.

Bids shall be valid for a period of 120 days after bid opening and must be accompanied by a bid security of one hundred fifty thousand (150,000) United States Dollars.

Bids must be delivered to the address below no later than Thursday, September 1st 2011 at 12:00 noon, at which time they will be opened in the presence of bidders' representatives who choose to attend. Late bids will be rejected.

A Contractor will be selected in accordance with the procedures set out in the World Bank's Guidelines; Procurement under IBRD Loans and IDA Credits (current edition).
