These works located at Lielvarde Airfield, Latvia are part of the Capability Package (CP) 5A0062 "Operational Facilities in the Seven New Nations".

- 2. The International Competitive Bidding (ICB) will be conducted in accordance with reference 1, which stipulates that the Host Nation (or designated Procurement Agent), at the earliest possible moment, even before the request for authorisation to commit funds is submitted issues a Notification of Intent (NOI) to Invite Bids to the diplomatic representative of the participating countries in the capital of the Host Nation (or of the country of the designated Procurement Agent).
- 3. This letter constitutes a Notification of Intent to invite Bids for the subproject entitled "2AF 33007-0, Provision of POL Facilities".

SUMMARY DESCRIPTION AND COST ESTIMATE OF PRESENT NOTIFICATION

GENERAL

1. NSPA has been designated as the Procurement Agent on behalf of the Latvian Ministry of Defence as Host Nation for the acquisition of CP 5A00062 "Operational Facilities in the seven New Nations" consisting of the following project:

- 2. Despite the fact that the pre-existing airfield conditions were sufficient for the Latvian Air Force purposes, CP 5A0062 aims at upgrading airfields to NATO standards, to be used for NATO sources. Once upgraded, the airfields could be considered for any further development as any other NATO airfield through other CPs.
- 3. For the above-mentioned project it is foreseen that the execution of these works will be done by a single commercial source. Activities will be coordinated with the on-going works performed as part of CP 5A0062.

REQUIRED ASSETS AND SUMMARY DESCRIPTION

- 4. Several projects are part of the reconstruction of the Lielvarde Airbase in Latvia. This procurement will be for Block No.7 of the Lielvarde Airfield project. Blocks 2, 3 & 8 (already solicited) may be concluding and 4, 5 & 6 are expected to run in parallel. Further information on these Blocks will be made available at a bidders conference.
- 5. Detailed requirements will be provided in the Statement of Work (SOW) that will be issued with the ICB documentation.

ESTIMATED VALUE OF THIS CONTRACT

6. The cost is estimated to be somewhere between 3.8 and 4.2 Million EURO.

- 9. The envisioned bidding method is the "One-Step International Competitive Bidding (ICB) Procedure".
