ΘΕΜΑ: Πιστοποίηση μονάδων παραγωγής για εξαγωγές στην Αίγυπτο.

Σχετ: έγγραφό μας ΑΠ 4231/28.1.2016

Σε συνέχεια ανωτέρω σχετικού και κατόπιν διευκρινίσεων του Υπουργείου Εμπορίου και Βιομηχανίας της Αιγύπτου, αποστέλλουμε για ενημέρωσή σας τα εξής:

- α) Διάταγμα 43/2016 που περιγράφει τη διαδικασία εγγραφής και περιέχει τον κατάλογο των απαιτούμενων δικαιολογητικών εγγραφής.
- β) Κατάλογος προϊόντων Συνδυασμένης Ονοματολογίας που εμπίπτουν στις διατάξεις των Διαταγμάτων 992/2015 (σας έχει ήδη αποσταλεί) και 43/2016.

Η καταχώρηση/εγγραφή των επιχειρήσεων γίνεται ηλεκτρονικά και μόνο μέσω της ιστοσελίδας του Υπουργείου Εμπορίου (www.goeic.gov.eg/en/index_r.asp) η οποία όμως παραμένει προς το παρόν ανενεργή.

Επισημαίνουμε, πάντως, ότι συνεχίζονται οι διαβουλεύσεις μεταξύ των αρμόδιων επιχειρηματικών φορέων και του Υπουργείου Εμπορίου της Αιγύπτου προκειμένου να αποσαφηνιστούν κάποια κρίσιμα τεχνικά σημεία αναφορικά με την εφαρμογή των διατάξεων ή και, ακόμα, να επιδιωχθούν κάποιες τροποποιήσεις οι οποίες θα διευκολύνουν τις συναλλαγές και δεν θα προκαλέσουν την αντίδραση (αντίποινα) των θιγόμενων εμπορικών εταίρων.

Κατόπιν, επίσης, συνάντησης του Γραφείου Οικονομικών και Εμπορικών Υποθέσεων στο Κάιρο με την εκεί επικεφαλής της Διεύθυνσης Εμπορίου της Αντιπροσωπείας της ΕΕ για το ανωτέρω θέμα, σημειώνουμε τα παρακάτω:

- Η έναρξη ισχύος του διατάγματος 992/31-12-2015 μετατίθεται χρονικά για δύο μήνες, διάστημα κατά το οποίο θα πρέπει να περατωθεί η διαδικασία εγγραφής στο εν λόγω μητρώο.
- Στην περίπτωση όπου αλλοδαπή επιχείρηση διαθέτει συνδεδεμένη εταιρικά επιχείρηση στην Αίγυπτο τότε, κατά πάσα πιθανότητα, η πρώτη θα εξαιρεθεί από την υποχρέωση εγγραφής της μητρώο.

• Στην περίπτωση που ανακύψουν θέματα πιστοποίησης (ή χρήσης εμπορικού σήματος από αλλοδαπή επιχείρηση, το οποίο δεν έχει καταχωρηθεί), ο νόμιμος εκπρόσωπος της εξαγωγικής επιχείρησης δύναται, αφού προχωρήσει στην υποβολή των διαθέσιμων στοιχείων, να ζητήσει, εκ των υστέρων, επιτόπια επιθεώρηση από τις αιγυπτιακές αρχές για την πιστοποίηση των ανωτέρω.

Με την ευκαιρία αυτή και κατόπιν σχετικών ερωτημάτων ελληνικών επιχειρήσεων προς το Γραφείο ΟΕΥ, αναφορικά με το απαιτούμενο πιστοποιητικό διαχείρισης ποιότητας χρήζει διερεύνησης εάν μεταξύ των δραστηριοτήτων του Εθνικού Συστήματος Διαπίστευσης (ΕΣΥΔ) – το οποίο είναι συνδεδεμένο με τον οργανισμό International Laboratory Accreditation Cooperation (ILAC) - συγκαταλέγεται και η κάλυψη των ιδιωτικών εταιρειών, οι οποίες εκδίδουν εν λόγω πιστοποιητικά σε ελληνικές επιχειρήσεις.

Ministry of Trade and Industry Decree No. 992 of the Year 2015

Regarding the Rules organizing the Registration of the Factories qualified to Export Products thereof to the Arab Republic of Egypt

Minister of Trade and Industry

After perusal of Law No. 118 of the year 1975 on Import and Export;

Ministerial Decree No. 770 of the year 2005 with regard to the statute of rules executing the provisions of Law No. 118 of the year 1975 referred to;

The approval of the economic ministerial committee in its session held on 28/12/2015; and

Based on the proposition of the Trade Agreements and Foreign Trade Sectors;

DECREED THE FOLLOWING:

(Article One)

A register shall be created in the General Organization for Export and Import Control for the factories qualified to export the products listed in the attached statement to the Arab Republic of Egypt.

These products imported for trading may not be released unless they are produced by the factories recorded in that register.

A decree of the Minister concerned with foreign trade shall be issued for recording in or removing from that register and he may exempt from any or all of the registration conditions in the cases determined thereby.



(Article Two)

For recording in the register referred to, the following shall be adhered to:

The Registration application shall be submitted by the legal representative of the factory or the owner of the trademark or his authorized deputy supported by the following certified documents:

- Copy of the license issued for the factory;
- Certificate of the legal entity of the factory and the items produced thereby;
- The trademark of the product and the trademarks produced by means of a license from the owner thereof;
- Certificate proving that the factory applies a quality control system, abides by the environmental standards and complies with the standards of the International Labor Organization and the international treaties organizing this issue; such certificate shall be issued by an entity recognized by the International Laboratory Accreditation Cooperation (ILAC) or an Egyptian or foreign governmental entity approved by the Minister concerned with foreign trade;
- Statement of the factories manufacturing under the trademark in case the application is submitted by the owner of the trademark; and
- Acknowledgment from the factory that it accepts the inspection which shall be carried out by a technical team to ensure the fulfillment of the standards of the environment and work safety and enable them to check that out.

(Article Three)

This Decree shall be published in Al-Wakaye Al-Mesreya / Government Bulletin and it shall come into force two months after the date of its publication.

Decree No. (43) of the year 2016

On

Amending the Rules Governing the Registration of the Factories Eligible for Export to the Arab Republic of Egypt

The Minister of Trade and Industry

Having regard to Law No. 118 of 1975 on Import and Export,

Having regard to The Ministerial Decree No. 770 of 2005 on the Executive Regulation implementing the referred to Law No. 118 of 1975,

Having regard to the Ministerial Decree No. 992 of 2015 on the rules governing the Registration of the Factories Eligible for Export to the Arab Republic of Egypt, and

Having regard to the memorandum of Trade Agreements & Foreign Trade Sectors,

Has decreed

(Article 1)

A record of the trademark owners' factories and companies eligible to export the products, mentioned in the referred to statement, to Egypt shall be created at the General Organization for Export and Import Control (GOEIC).

These products imported for the purpose of trading may be released only if they are produced in the factories or imported from the companies bearing the trademark or its distribution centers registered in the record.

The Minister of Foreign Trade is entitled to make decisions for registration and cancellation in the record, and may grant an exemption from any or all registration requirements in some cases decided thereby.

(Article 2)

The following conditions for registration in the record shall be fulfilled:

1- For the Factories:

The factory's legal representative, whomever he deputizes or agent thereof shall submit the application for registration supported with the following authenticated documents:

- A certificate of the legal status of the factory and the production license thereof;
- A statement of the products produced by the factory and the trademarks thereof,
- The trademark of the product and the trademark used under license from the owner,
- A certificate to prove that the factory implements a quality control system. Such
 certificate shall be issued from the International Laboratory Accreditation Cooperation
 (ILAC), the International Accreditation Forum (IAF) or from any Egyptian or foreign
 government entity approved by the Minister of Foreign Trade.

2-For the Trademark Bearing Companies.

The trademark bearing company's legal representative, whomever he deputizes or agent thereof shall submit the application for registration supported with the following authenticated documents:

- A certificate to prove that the trademark is registered and that the produced products are registered under this trademark,
- A certificate from the trademark bearing company identifying the distribution centers permitted to distribute the products bearing the trademark,
- A certificate to prove that the factory implements a quality control system. Such
 certificate shall be issued from the International Laboratory Accreditation Cooperation
 (ILAC), the International Accreditation Forum (IAF) or from any Egyptian or foreign
 government entity approved by the Minister of Foreign Trade,

3-In suspicion of the submitted documents, the registration may not be made except when verifying the documents. Upon the request of the applicant and after having the approval of the Minister of Foreign Trade, the checking on the name of the company to verify the validity of the documents may be conducted.

(Article 3)

All what contradicts or being inconsistent with the provisions of such decree shall be cancelled.

(Article 4)

This decree shall be published in the Egyptian Official Gazette and shall entered into force after two months from the date of publication therein.
