The aim of this project is to build a new concrete bridge which shall replace the existing steel structure bridge over the Bistrica River located in the north of Kosovo between Zvecan and Leposavic

Municipalities on road MSR BULL. The longitudinal slope of the bridge is steady with gradient of ~0,0%, while the plan alignment is straight, The whole length of the bridge from wing wall towing wall is 42.30 m.. Before demolishing and building works starts, it is required to prepare a bypass road integrated with existing KFOR Military Bridge (JORDY) and regulate traffic flow.
