### NOTIFICATION OF INTENT TO INVITE BIDS

- 1. Ministry of Defence of Romania intends to invite eligible companies to participate at "National Competitive Bidding Plus" ("NCB+") for the implementation of works of the NSIP projects at Feteşti Airfield, Romania:
  - 3AF35004 Restore and extend aircraft parking platform
  - 3AF35009 Provide aircraft maintenance apron

These projects are included in the Capability Package CP 5A0062 "Provide operational facilities in seven new nations" and are commonly funded from NATO Security Investment Program.

## 2. Summary Description of Projects:

The project 3AF35004 - Restore and extend aircraft parking platform includes the following main works:

- Rehabilitation of ALPHA, BRAVO, CHARLIE, DELTA, ECHO taxiways (including runways and access roads to micro-hangars);
- Reinforcement and extension of existing aprons (aircraft apron, connection apron ECHO for access to micro-hangars, ALPHA apron for aircraft starting, ALPHA combat service apron, apron for BRAVO taxiway, apron for DELTA taxiway)
- Jet blast deflector;
- Runways and aprons markings;
- Design of service roads;
- Lighting system;
- Grounding system;
- Drainage installation.

The project 3AF35009 - Provide aircraft maintenance apron includes the following main works:

- Maintenance apron;
- Apron to hangar H1;
- Taxiways for access to maintenance apron and apron to hangar H1;
- Taxiways for access to maintenance apron and to apron for hangar H1;
- Lighting system;
- Grounding system;
- Drainage system.

"NCB+"

16. Bidding is conducted according to Governmental Decision no. 34/2006 and is open to all bidders from NATO member countries ("25B"). Only eligible companies from NATO member countries ("25B") are allowed to participate in the bidding "NCB+". Complete set of bidding documents in Romanian language, including qualification requirements, bidding data sheet, "Cahier des Charges", technical specifications, drawings, bill of quantities, security guarantee and contract forms, are available on the Romanian Government Official site for Bidding www.e-licitatie.ro with identification no. 156008/06.12.2014.

All bids shall be accompanied by a Bid Security of 100.000 euro.

The contracting authority shall demand performance guarantee representing 10% of the overall value of the contract.

To qualify for award of the Contract, bidders shall meet the minimum qualifying criteria as specified in the bidding documents. For the qualified companies, the criterion for awarding the contract is the lowest price.

- 17. Companies from NATO member countries specialized in the project subject need the approval from Government or qualified Authority of their country of origin by submitting "DECLARATION OF ELIGIBILITY", which should be forwarded in a form as specified in Enclosure A.
