ΘΕΜΑ: Σύνοδος για το Μέλλον της Ουκρανία (Βρυξέλλες, 18/4/2024)

Σύμφωνα με ενημέρωση από Μόνιμη Ελληνική Αντιπροσωπεία στην ΕΕ, η Ευρωπαϊκή Επιτροπή (DG NEAR) και η European Business Summits διοργανώνουν στις 18 Απριλίου τ. έ. στις Βρυξέλλες, Σύνοδο για το μέλλον της Ουκρανίας με τίτλο "Ukraine's Future Summit" και ειδικότερη θεματική με στόχευση στις επενδύσεις ("Investing in Tomorrow's Potential").

Η ανοικοδόμηση της Ουκρανίας θα αποτελέσει ένα από τα μεγαλύτερα αναπτυξιακά μεταπολεμικά εγχειρήματα σε ευρωπαϊκό επίπεδο, το συνολικό κόστος της οποίας, σύμφωνα με κοινή εκτίμηση Παγκόσμιας Τράπεζας, Ευρωπαϊκής Επιτροπής, Ηνωμένων Εθνών και της ουκρανικής Κυβέρνησης, αναμένεται να ανέλθει σε 411 δισ. δολ. ΗΠΑ.

Στόχος της Συνόδου είναι η έγκαιρη και εις βάθος ενημέρωση της επιχειρηματικής κοινότητας των κ-μ, σχετικά με τις πιο πρόσφατες εξελίξεις στις προσπάθειες της ΕΕ για την ανοικοδόμηση της Ουκρανίας, και η δημιουργία δεσμών συνεργασίας μεταξύ των ευρωπαϊκών επιχειρήσεων, από όλα τα κ-μ της Ένωσης, με αντίστοιχες ουκρανικές.

Προωθούμε, συνημμένως, την πρόσκληση για τη Σύνοδο, καθώς και σχέδιο Προγράμματος (αμφότερα στα Αγγλικά), και παρακαλούμε για την ενημέρωση των επιχειρήσεων μελών σας.




