- This Invitation for Bids follows the Advance Action on Procurement and Recruitment of Consultants published on Asian Development Bank's Web Site on 19 August 2009.
- 2. The Republic of Armenia has received a loan from the Asian Development Bank (ADB) towards the cost of the North-South Road Corridor Investment Program, Tranche 1 Project, and it intends to apply part of the proceeds of this loan to payments under the contract for Reconstruction of Existing 11.71 Km (from 18+370 to 30+080) Yerevan-Ashtarak Part of North-South Road Corridor. This contract will be jointly financed by ADB and Republic of Armenia. The eligibility rules and procedures of the ADB will govern the bidding process.
- The Ministry of Transport and Communication (hereinafter the Employer) of the Republic of Armenia now invites sealed Bids from eligible Bidders for Reconstruction of Existing 11.71 Km (from 18+370 to 30+080) Yerevan-Ashtarak Part of North-South Road Corridor. The Contractor shall reconstruct pavement, improve drainage and shoulders, road safety, and repair existing structures on Yerevan-Ashtarak Road (from 18+370 to 30+080). The project road is located north-west of Yerevan, the capital of Armenia at an altitude between 850 and 1,250m above mean sea level. The completion period is 533 days.

- International Competitive Bidding will be conducted in accordance with ADB's Single-Stage:
   One-Envelope Bidding Procedure and is open to all Bidders from eligible source countries.
   Only eligible bidders with the following key qualifications should participate in this bidding:
  - a. Having a minimum average annual construction turnover of US\$ 20 Million calculated as total certified payments received for contracts in progress or completed, within the last 5 years;
  - Having experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least 5 years prior to the applications submission deadline;
  - c. Participation as contractor, management contractor, or subcontractor, in at least 3 contracts within the last 6 years, each with a value of at least US\$ 20 Million that have been successfully or are substantially completed and that are similar to the proposed works;
  - d. Complies with relevant Armenian laws and regulations.
